CASA'S VISION IS TO ASSIGN A CASA VOLUNTEER ADVOCATE TO EVERY CHILD IN ITS SERVICE REGION. CASA STAFF RECRUITED AND TRAINED 90 NEW COMMUNITY MEMBERS TO BECOME CASA VOLUNTEER ADVOCATES. CASA SUPPORTED THE WORK OF 240 ACTIVE VOLUNTEERS WHO ADVOCATED FOR 550 CHILDREN. CASA ADVOCATES WORKED WITH SYSTEM COLLABORATORS AND THE COURTS AND ULTIMATELY ENSURED THAT 146 CHILDREN'S CASES ACHIEVED PERMANENCY.
